- 6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2076/09/16 at the office of Barekot Rural Municipality, Limsa Jajarkot. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRS. 2,30,000.00 which shall be valid for 30 days beyond the validity period of the bid (i.e. 2077.01.16) For the purpose of Bid Security: Bidder's should submit their Bid security through Bank Gurantee only.
